2023-24 School Safety Plan

Each school within the Cascade Union Elementary School District has a Comprehensive School Safety Plan that is developed in consultation with the Anderson Police Department, the Shasta County Sheriff's Department, School Site Council, and School and District administration. It is reviewed on an annual basis. Professional Development

The Cascade Union Elementary School District annually schedules time for professional development sessions for our teachers. Additional site-based staff development opportunities occur at school sites after school, during evenings, and over summer vacation. Various training opportunities have included topics such as Smartboard Training, Life Space Crisis Training, Capturing Kids Heart Training, West Ed Training and other offerings by district teachers.
